Drink + Food Options

Minimum Spend

A \$3K minimum bar spend is required for use of the upstairs event space. This an be via a tab, on consumption or a mix of both options.

On Consumption

Guests may also have the access to pay for their own drinks option for the duration of your event.

Bar Tab

A pre-paid nominated amount can be placed on a bar tab controlled by you, with selected drink options or an open bar option.

Catering

We have established relationships with local restaurants who are happy to cater to your event needs. Just let us know what your mood is and we can source some options for you. We are also open to you bringing in your own catering, we can also supply and help assist in setting up a grazing table for you at no extra cost.

Terms and Conditions

Deposit and Payment

- A 10% deposit of \$300 is required to secure your booking.
- Management reserves the right to cancel the booking should this payment not be received.
- Cancellations made more than 30 days prior to the event will receive a refund of full deposit.
- Events cancelled due to a covid related lockdown of the state, city or venue will be eligible for a refund of full deposit.
- Cancellations made less than 14 days notice will forfeit the deposit.
- Cancellations made less than 7 days notice will be liable for 50 percent of the minimal spend amount.
- Cancellations made less than 48 hours before the event will be liable to pay for the full minimum spend amount.

Food & Drinks

- Your chosen food and drinks options must be confirmed 2 weeks prior to your event.
- If opting for a bar tab, your tab balance is required to be paid in full on arrival.
- Additional food and drink items can be charged on the night via credit card or cash.

House Rules

- Any additional requirements will be chargeable to you.
- Unfortunately due to licensing requirements, guests under 18 are not permitted, regardless of parental supervision.
- The client is expected to conduct their event in a legal and respectable manner, and is responsible for the conduct of its guests and invitees. Please also note that in line with Australian legislation relating to responsible service of alcohol, management reserve the right to terminate an event, refuse service to any guest deemed intoxicated, or take responsible action to assist any intoxicated guest from the premises.

Damages

- You will be responsible for any repair costs for any fittings or fixtures in or around the premises which have been damaged by you or any of your guests. Any costs associated with repairs or replacements will be charged directly to your credit card.
- BAD DECISIONS bar will not be responsible for loss or damage of property left on the premises during your event.

Decorations

- BAD DECISIONS will make early access to the room available one hour prior to the commencement of the event for any decorations and other set up.
- All decorations are the responsibility of the customer.
- Nothing is to be nailed, screwed, stapled or adhered to the venue without the prior approval of the venue manager.

Minimum Spend / Room Hire

• There is no separate charge for room hire, however we do require a \$3K minimum spend over the bar. In the event that the minimum spend is not met the deposit will be forfeit up to the amount required to meet the minimum spend level. In the event that the minimum spend level is still not met, the balance must be paid on the day/night of the event.
